MOVE-UPS

The last day for move ups for Saturday is April 29, 2024 at 6pm. Day to day move-ups must be received within ½ hour after the last class of the day. Day to day move-ups must be in writing at the site. NO emails or phone calls.

MEASURING

There will not be a VMO at this trial. The judge of record will need to measure all dogs that do not have a valid height card if over 2yrs old or a temporary measurement if under 2yrs old, prior to the first run for the dog that day per Chapter 2, Section 5, Paragraph 5, Regulations for Agility Trials and Agility Course Test (ACT)

COURSE MAPS

Course maps will be posted to the Trial Secretary's website (www.awesomedogsagility.com) after midnight each trial day and will be posted at the trial site each morning.

DIRECTIONS TO SITE

From North - Take 29 south through the Culpeper exits. Go about 6 1/4 miles and turn right on Rt 609 (Hoover Rd). Go 2.3 miles and turn right on Rt 607 (Ridgeview Rd). Go 1.7 miles to Walnut Hill Farm on the right.

From South - Take 29 north past the town of Madison. After about 8 miles turn left on Rt 609 (Hoover Rd). Go 2.3 miles and turn right on Rt 607 (Ridgeview Rd). Go 1.7 miles to Walnut Hill Farm on the right.
